TOOSCS monthly fees are averaged over the ten months of the school year. While some months have a greater number of childcare days, and some have fewer, the monthly rate stays the same.

Monthly fees do not include care on Pro-D days, or during Winter, Spring and Summer breaks. Additional fees and separate registrations are required for these days.

TOOSCS participates in the BC Government's Child Care Fee Reduction Initiative. Beginning September 1, 2026, the fee reductions shown here will be automatically applied for families enrolled in our Before and After School Care, and Preschool programs.
